OF THESE, 271 ATTENDED EDUCATIONAL AWARENESS PROGRAMS (83% RETAINED AT LEAST 90% OF THE INFORMATION PRESENTED), 282 PARTICIPATED IN A GENERAL ASSESSMENT, 21 PARTICIPATED IN TEEN INTERVENE (A BRIEF INTERVENTION THERAPY FOR CHEMICAL USE), AND 6 PARTICIPATED IN A RESTORATIVE JUSTICE CONFERENCE. YSB ALSO HELPED 282 YOUTH COMPLETE 2,837 HOURS OF COMMUNITY WORK SERVICE.
